When completing this form, refer to the <u>Registers of interests notes</u>, <u>Local Government Act</u> 2009/<u>Local Government Regulation 2012</u> and <u>City of Brisbane Act 2010/City of Brisbane Regulation 2012</u>. If you are unsure of your obligations it is strongly recommended that you seek independent legal advice.
